“Win a Trip for 2 to Egypt, Inca Trail or Kenya Wildlife Safari ” Giveaway

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1) **Eligibility:** The “Win a Trip for 2 to **Egypt, Inca Trail or Kenya Wildlife Safari**” Giveaway (the “Promotion”) is open only to legal residents of the United States (excluding NY, FL, RI, AZ & where prohibited) who are at least eighteen (18) years old at the time of entry. Employees, officers and representatives of Reverb (the “Sponsor”) and Intrepid Travel (the "Prize Partner), and their respective, affiliated companies, vendors, advertising/promotion companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee (collectively, the “Promotion Entities”), are not eligible. Subject to all federal, state, municipal, provincial and local laws and regulations. Odds of winning the prize offered will depend upon the total number of eligible entries received.

- 3) **To Enter: simply visit** www.reverb.org/project/lilith/intrepid.htm and follow the links and instructions for entry. After you have fully completed the entry form and submitted the required information, you will be automatically entered into the Promotion. **Limit: only one entry per person** during the Promotion Period.

Note: Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.

- 4) **Winner Selection/Prize Draw:** A random drawing will be conducted on/about **August 23, 2010** from among all eligible entries received by Sponsor, and whose

decisions as to the fair administration of the Promotion and the selection of the potential winner are final and binding. The potential Grand Prize winner will be notified by mail, phone, or email, and must sign respond, within ten (10) days of the date of notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release (if U.S. resident) in order to claim his/her prize. - **7-night/8-day trip for 2 to on Intrepid Travel's Inca Trail vacation package.** The trip can be viewed at www.intrepidtravel.com/GXB. Trip includes coach airfare from a major airport nearest the winner's home to Lima, Peru, accommodations (Hotels (4 nts), camping (3 nts)), some meals (6 Breakfasts, 3 Lunches, 3 Dinners) and local transportation while on the trip. Approximate retail value of this prize: **\$5200**.
- **7-night/8-day trip for 2 to on Intrepid Travel's Kenya Wildlife Safari vacation package.** The trip can be viewed at www.intrepidtravel.com/YOI. Trip includes coach airfare from a major airport nearest the winner's home to Nairobi, Kenya, accommodations (Hotel (1 nt), participatory camping (6 nts)), and local transportation while on the trip. Approximate retail value of this prize: **\$4480**. PLEASE NOTE: winner is responsible for a \$330 trip kitty per person; the trip kitty pays for group camping meals.
